Today's Guest Speaker; Special Agent Rick Maier (FBI)

Special Agent (SA) Richard (Rick) Maier is the Federal Bureau of Investigation (FBI) Cincinnati (CI) Division, Weapons of Mass Destruction Coordinator (WMDC).

SA Maier joined the FBI in 2000. Prior to assignment to the Cincinnati Division, SA Maier served as the Washington Field Office (WFO) WMDC. There SA Maier was a member of WFO's Special Operations Squad; FBI's special response assets which included; tactical, hazmat, counter-explosive, evidence recovery, and WMD operations. This squad works in conjunction with WFO's Joint Terrorism Task Force (JTTF) and is the FBI's First Responders to major terrorism incidents.

SA Maier is a Hazardous Materials and Evidence Technician. SA Maier has responded to processed multiple criminal and WMD crime scenes during his tenure with the FBI. Some of these incidents include, the 9/11 Terrorist attack on the Pentagon, the October 2001 Anthrax attack and surrounding events, various WMD threats, bank robberies, cyber-crimes, homicides and missing persons cases.

SA Maier is currently responsible for the FBI Cincinnati's WMD interagency liaison, response and prevention program and brings with him over twenty-seven years of WMD experience.

SA Maier coordinates these efforts with other State, Local and Federal agencies within the Cincinnati Division.
